# Session I: Setting the scene. Presenting HFHI research and recommendations and response by EU policy makers

HFHI and USAID have been implementing the REELIH project in several countries to address energy poverty by developing models to scale up energy efficiency renovations of multi-apartment buildings. They use these projects and commission research to better understand the connection between residential energy efficiency and energy poverty. The most recent research initiative is presented by research partners MRI and BPIE with a focus on developing a practical definition of energy poverty and recommendations for policy makers. EU policy makers from the European Parliament, the European Commission and from the Member States are asked to respond to the recommendations.

# **Session 2: Financing residential energy efficiency**

Energy poverty alleviation of vulnerable consumers living in multi-apartment buildings requires scaling up of investment into a deep renovation of these buildings. A mixed financing model seems feasible and sustainable where a good combination of community savings, subsidies and bank loans can provide the necessary investment. There are well-developed schemes in Central Europe and good schemes for single houses in many countries of the Energy community, but the community lending needed for the financing of the energy efficiency renovations of multi-apartment buildings is missing. In this session, first we are having an introduction about the bottlenecks of energy efficiency investment into residential energy efficiency and then we are asking the response from key international financing institutions and other presenting some best practices by other organizations.

### Session 4: EU policies and implementation at national level

Recently introduced Renovation Wave Strategy package gives a unique opportunity for EU Member States and accession countries to boost the renovation of their building stock. This year, the European Commission's leading initiatives under Renovation Wave Strategy, such as Affordable Housing Initiative or New European Bauhaus, are being shaped to best reflect the needs identified by different stakeholders representing the EU countries. Likewise, Recommendations on Energy Poverty address the issue, however, it is still important to recognize the different regional contexts of the problem. In this session, first we are having a summary presentation about the new EU policies and then we are asking representatives of national and local government to show how these EU policies are/can be implemented at their level.

# Session 5: Improving homeowner associations' legislation. Closing remarks

National governments have a crucial role to play in the creation of an enabling environment for HOAs to become responsible and reliable entities in the marketplace. Without proper legislation about the management of HOAs, the HOAs can only hardly be restructured in a way to ensure they collect and build their own resources for maintenance of the co-owned spaces. In the CEE/CIS region, legislation about management of the HOAs is not transparent and banks do not trust HOAs as reliable entities to lend the money to. This is one of the main bottlenecks in the process of renovating residential building stock. The session will introduce the GAP analysis which showcases Slovakia as a leading example of how to empower the HOAs through establishing proper legislative background for these entities and for the investment in residential sector. HFH Armenia has been long working on the legislation changes in their national law and their work bring the first successes. Their experience in influencing the legislation changes and working with national government together with identification of following challenges to be tackled after the legislation is set, will be discussed during this session.
